1. About this document

This target market determination (TMD) seeks to offer consumers, distributors and staff with an understanding of the class of consumers for which this product has been designed, having regard to the objectives, financial situation and needs of the target market.

This TMD applies to the Global Sustainable Equity Active ETF issued by Janus Henderson Investors (Australia) Funds Management Limited (ABN 43 164 177 244) referred to in the Global Sustainable Equity Active ETF Product Disclosure Statement.

2. Class of consumers that fall within this target market

The information below summarises the overall class of consumers that fall within the target market for the Global Sustainable Equity Active ETF, based on the product key attributes and the objectives, financial situation and needs that this product has been designed to meet.

A consumer (or class of consumer) might intend to hold a particular investment product as part of a diversified portfolio. In these scenarios, the investment product should be assessed against the consumer's attributes for the applicable part of the portfolio, instead of against the consumer's portfolio as a whole.

The Global Sustainable Equity Active ETF is for those seeking exposure to a diversified global portfolio of companies whose products and services contribute to the development of a sustainable global economy.

Product description and key attributes

The key product attributes of the Global Sustainable Equity Active ETF are:

- The Global Sustainable Equity Active ETF seeks to provide capital growth over the long term and to achieve a total return after fees that exceeds the total return of the Benchmark (MSCI World Index (net dividends reinvested) in AUD) over rolling five year periods;
- The fund will typically invest in companies strategically aligned with trends such as climate change, resource constraints, growing populations, and ageing populations. The fund avoids investing in fossil fuels and companies that stand to be disrupted by the transition to a low-carbon economy;
- Income distributions are generally made on a semi-annual basis;
- A management fee of 0.80% per annum of the asset value of the fund is charged; and
- As a traded security, investors are able to enter and exit the investment anytime on the Australian Securities Exchange during trading hours.

Objectives, financial situation, and needs

This product has been designed for individuals who:

- Are seeking capital growth through exposure to an actively managed global equity fund;
- Are willing to pay the fund's management fee through the value of their invested capital;
- Would be comfortable to invest their capital for a minimum suggested timeframe of at least five years;
- Have a high risk tolerance and are willing to accept the risks of losing some of their invested capital; and
- Want the flexibility of investing in an ETF.

Consistency between target market and the product

The Global Sustainable Equity Active ETF is likely to be consistent with the likely objectives, financial situation and needs of the class of consumers in the target market. This is based on an analysis of the key terms, features and attributes of the product and a finding that these are consistent with the identified class of consumers. Individuals will need to consider whether this product meets their specific objectives, financial situation and needs. The fund aims to meet its performance target as assessed in relation to its objective and benchmark, and also aims to pay semi-annual distributions.
