Target Market Determination

TARGET MARKET SUMMARY

This product is intended for use as a core allocation through to a satellite allocation for a consumer who is seeking capital preservation and income distribution and has a medium risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum 3-year investment timeframe and needs daily access to capital.

The Fund is an exchange traded fund (ETF) and is generally only available to consumers through the ASX via a broker.

INVESTMENT PRODUCTS & DIVERSIFICATION

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (for example, with an intended product use of minor allocation). In such circumstances, the product should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a balanced or moderate diversified portfolio with a minor allocation to growth assets. In this case, a product with a High risk/return profile may be consistent with the consumer's objectives for that minor allocation notwithstanding that the risk/return profile of the consumer as a whole is Medium. CONSUMER'S INVESTMENT OBJECTIVE

Capital Growth		The Fund aims to provide consumers with a return that tracks the performance of the iBoxx \$ Treasuries Index (AUD Hedged) (the "Index") before fees and expenses. The Fund consists of an underlying fund that holds a portfolio of USD-denominated bonds issued by the US government. The Fund is also currency hedged into Australian dollars.
Capital Preservation		By virtue of the nature of fixed income securities they are generally considered to be defensive assets. Defensive assets offer lower return potential over the medium to long term but are lower risk and tend to exhibit lower levels of price volatility. The Fund's underlying bonds are also guaranteed by the US government, therefore, consumers seeking capital preservation over the long term are therefore considered to be within the target market. Fixed income assets typically offer lower return potential; therefore, the Fund is not considered suitable for consumers who are seeking capital growth.
Income Distribution		The Fund aims to offer a regular source of distribution income and may be considered to offer a consistent and reliable source of income. The Fund will, therefore, likely be suitable for consumers who are seeking income distribution. The Fund is not designed to provide tax effective income for a particular class of consumer. Therefore, the Fund is not likely to meet the objectives of consumers who have a primary objective of tax effective income distribution.

CONSUMER'S INTENDED PRODUCT USE (% OF INVESTABLE ASSETS)

Solution/Standalone (up to 100%)		The Fund provides exposure to a diverse portfolio of bonds issued by the US government and is currency hedged into Australian dollars. The portfolio diversification of the Fund is low on the basis that the Fund offers exposure to a single asset class and a single issuer, despite offering exposure across a broad range of individual bonds. The Fund is therefore not considered to be suitable as a standalone solution or major allocation portfolio solution. For consumers with an objective of capital preservation or income distribution and a medium risk / return profile, the Fund may be suitable for the target market for use as a core component, minor allocation, or satellite allocation.

Consumers with minimum 3 year investment timeframe are all likely to fall within the target market.

CONSUMER'S RISK (ABILITY TO BEAR LOSS) AND RETURN PROFILE

Low		Because the Fund primarily holds fixed income assets, which offer low return potential but are typically lower risk, consumers with a medium risk profile are considered to be in the target market.
Medium		
High		For higher risk profile categories, the Fund does not meet their return expectations. Its yield driven, historically modest returns do not satisfy the high growth targets associated with the High category. Its defensive, income-oriented nature is inconsistent with the return maximisation goals of the Very High category. And it lacks the speculative or leveraged characteristics required to deliver the accelerated, outsized short-term returns expected in the Extremely High category.
Very High		The Fund has a risk band of SRM 7. However, USTB may be suitable for consumers with a medium risk profile because the Fund offers historically stable, income focused returns with only moderate variability and limited growth potential. This aligns with consumers seeking modest returns from defensive fixed income assets rather than the higher growth or speculative outcomes associated with higher risk products.

CONSUMER'S RISK (ABILITY TO BEAR LOSS) AND RETURN PROFILE

This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For Trustees (note the bands in the SRM guidance differ from the bands used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some products may use leverage, derivatives or short selling; may have liquidity or withdrawal limitations; may have underlying investments with valuation risks or risks of capital loss; or otherwise may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.

A consumer's desired product return profile would generally take into account the impact of fees, costs and taxes.

Medium	For the relevant part of the consumer's portfolio, the consumer: • has a moderate or medium risk appetite, • seeks low volatility and potential losses (e.g. has the ability to bear up to 4 negative returns over a 20 year period (SRM 3 to 5)), and • is comfortable with a moderate target return profile. The consumer typically prefers defensive assets (for example, fixed income).
High	For the relevant part of the consumer's portfolio, the consumer: • has a high risk appetite, • can accept high volatility and potential losses (e.g. has the ability to bear up to 6 negative returns over a 20 year period (SRM 5 or 6)), and • seeks high returns (typically over a medium or long timeframe). The consumer typically prefers growth assets (for example, shares and property).
Very High	For the relevant part of the consumer's portfolio, the consumer: • has a very high risk appetite, • can accept very high volatility and potential losses (e.g. has the ability to bear 6 to 7 negative returns over a 20 year period (SRM 6 or 7)), and • seeks to maximise returns (typically over a medium or long timeframe). The consumer typically prefers high growth assets (such as high conviction portfolios, hedge funds, and alternative investments).
Extremely High	For the relevant part of the consumer's portfolio, the consumer: • has an extremely high risk appetite, • can accept significant volatility and losses, and • seeks to obtain accelerated returns (potentially in a short timeframe). The consumer seeks extremely high risk, speculative or complex products which may have features such as significant use of derivatives, leverage or short positions or may be in emerging or niche asset classes (for example, crypto-assets or collectibles).

CONSUMER'S NEED TO ACCESS CAPITAL

This consumer attribute addresses the likely period of time between the making of a request for redemption/withdrawal (or access to investment proceeds more generally) and the receipt of proceeds from this request under ordinary circumstances. Issuers should consider both the frequency for accepting the request and the length of time to accept, process and distribute the proceeds of such a request. To the extent that the liquidity of the underlying investments or possible liquidity constraints (e.g. ability to stagger or delay redemptions) could impact this, this is to be taken into consideration in aligning the product to the consumer's need to access capital. Where a product is held on investment platforms, distributors also need to factor in the length of time platforms take to process requests for redemption for underlying investments. Where access to investment proceeds from the product is likely to occur through a secondary market, the liquidity of the market for the product should be considered.



DISTRIBUTOR REPORTING

Significant Dealings

Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning. The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC.

Dealings outside this TMD may be significant because:

- they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or
- they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer).

In each case, the distributor should have regard to:

- the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes),
- the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and
- the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the consumer).

Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if:

- it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter,
- the consumer's intended product use is solution/standalone,
- the consumer's intended product use is core component or higher and the consumer's risk/return profile is low, or
- the relevant product has a green rating for consumers seeking extremely high risk/return.
