Target market summary

This product is intended for use as a standalone or smaller component of an overall portfolio for a consumer who is seeking capital growth and has a very high to extremely high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum investment timeframe of 7 years or more, and who needs to withdraw their money on less than one week's notice.

The Fund is an exchange-traded product and is generally only available to consumers through the ASX.

Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (for example, with an intended product use of minor allocation). For example, a consumer may seek to construct a balanced or moderate diversified portfolio with a minor allocation to growth assets. In this case, a product with a High risk/return profile may be consistent with the consumer's objectives for that minor allocation notwithstanding that the risk/return profile of the consumer as a whole is Medium. This means the Fund's geared exposure is anticipated to vary between 143% and 167% of the Fund's net asset value on a given day. The Fund's returns will not necessarily be in this range over periods longer than a day, primarily due to the effects of rebalancing to maintain the daily target geared exposure range and the compounding of investment returns over time, as well as the impact of fees and costs. The Fund's returns over periods longer than one day may differ in amount and possibly direction from the daily target geared exposure range. This effect on returns over time can be expected to be more pronounced the more volatile the share market and the longer an investor's holding period. Gearing magnifies gains and losses and may not be a suitable strategy for all investors. Income Distribution: While the Fund may receive some dividend income, income generation is not a primary objective. The Fund may pay distributions on a semi-annual basis.
